Damage caused by pooled water may not be covered under these warranties. Always tie your boat cover down securely using the Carver tie-down kit and avoid letting water or snow stand on the boat cover. Standing water and snow will degrade the cover's water repellency and potentially cause mildew or premature leakage. To prevent this from occurring, Carver recommends the use of its boat cover support system, vented support poles, standard support poles or bows to raise center areas so that water, snow, and ice run off the cover.
